A \$25 administrative fee per person, per class will be deducted from all refund requests. A full refund will be given only if your class is canceled.

ETIQUETTE and GUIDELINES for Parents

1. Parental interaction can sometimes be confusing and/or distracting to children enrolled in Pony Camp. We recommend dropping off your child in a timely manner and picking up your child following the two or three-hour Pony Camp session. IF LATE WHEN PICKING UP, YOU WILL FIND YOUR CHILD IN THE "PETTING WONDERS ENCHANTED CORRAL" AREA. THERE WILL BE A CHARGE OF \$10.00 PER FIFTEEN MINUTES YOU ARE LATE. Extended stay service available.
2. Due to liability concerns, children who are not enrolled in Pony Camp are not allowed to be present during the camp (i.e., siblings, friends, relatives, etc.). Baby carriages, scooters, strollers, bicycles, etc. are not allowed in the barns, crosstie areas and walkways, because many horses can be startled or "spooked" which could, in turn, cause unfavorable conditions for those children who are taking their turn to interact with the horses or ponies.
3. Please apply sunscreen to your child(ren) **PRIOR** to arriving at Pony Camp. If you send sunscreen with your child(ren), your child(ren) will apply their own sunscreen. Sunscreen will not be provided by Pony Camp or management.
4. **Snacks** are provided only for the children enrolled in Pony Camp. Please advise the staff, if your child has any food allergies.
5. All participants will be assigned Horseback Riding Helmets and Boots with heels to wear for safety during the camp session. If parents would prefer to buy their own, prior to class, they can be purchased at Boot Barn, Lomita Feed Store or the Rolling Hills General Store. Please call if addresses or contact information is needed.
6. Parents are welcome to take pictures at Pony Camp. Please ask (or text preferably) your instructor, as to when your child may be riding. Use discretion . . . do not interfere with the Pony Camp in session.

Thank you for your anticipated cooperation in adhering to the above Pony Camp guidelines. It is our goal to have your child's participation in Pony Camp be a safe and enjoyable one!
